WHERE IS YOUR ARBITRATION FILING?

GOOD MORNING. As you are well aware Mr. Pandos thought it was a good idea to try and SCARE me last August using 2 cease and desist emails with a 48 hour deadline to respond (because the issue DEMANDED IMMEDIATE attention), DEMANDING a jury trial in state court and when that SCARE tactic didn't work he was forced to file that lawsuit he did in state court stating NO ARBITRATION was pending or contemplated.

Since then Mr. Pandos has not only LIED to the court with multiple FALSE statements, refused to participate in the COURT forum HE DEMANDED, IMMEDIATELY filed an appeal when Judge Troxell ruled the case to stay in state court, brought up an irrelevant domestic violence claim, claimed he's been RETRAUMATIZED after harassing me with his FRIVOLOUS lawsuit but has since DISAPPEARED from the case.

This was finally decided by the appeals court on 4/20/26 that the case should go to arbitration and if the arbitrator agrees that Mr. Pandos waived his rights to arbitration then the arbitrator could send the case back to state court.

On 4/21/26 I received an email from Holly Hotchkin signed by Mr. Moscagiuri proudly showcasing the appellate court's decision to send the case to arbitration. In that email she states if I have any questions or concerns to email Mr. Moscagiuri.

Considering the urgency this was given back in August with a 48 hour demand to take the website down I thought Mr. Pandos would've filed his

arbitration papers IMMEDIATELY (like he did with his appeal) or at the very least Mr. Moscagiuri would've filed them as he seemed to be the one that was sent to rescue Pandos.

On 4/25/26, after not hearing anything from Mr. Pandos or Mr. Moscagiuri for that matter, I was forced to send an email to them along with Ms. Hotchkin and Ms. Weeks demanding written confirmation whether arbitration had actually been initiated and if so the exact formal details, filings, forum and procedure. After not getting a response AT ALL, knowing Mr. Pandos wasn't gonna respond because he was "safe" being as he wasn't in court anymore, knowing that Mr. Moscagiuri was sent in as Pandos's savior, cried about me filing TOO FAST earlier and wasn't filing anything either; On 4/27/26 I was forced to send an email to the entire law firm asking how I could be harassed in such a manner by Mr. Pandos.

Even after this email to the entire law firm neither Mr. Pandos, Mr. Moscagiuri nor anybody else at that law firm filed any arbitration papers. On 4/29/26 I was forced to file arbitration papers myself with the American arbitration association, sent this information to your law firm and only THEN did I get a response.

Not only did Mr. Pandos spit in my face, tell me he wants to beat the crap out of me and take all my stuff but after I show up he starts crying, claims he's RETRAUMATIZED and disappears. Mr. Moscagiuri came in as Mr. Pandos "White shoe defender", thereby ENABLING him. Obviously that didn't work and although Ms. Hotchkin said to email Mr. Moscagiuri about the appeal, when I did, HE TOO refused to participate.

Then on 4/30/26 Ms. Benito sends me a email stating that the law firm will file a response accordingly. This is BIZARRE! Not only am I wondering what happened to William "The Harasser" Pandos but what happened to Mr Moscagiuri who Ms. Hotchkin said was gonna respond to arbitration questions??? How is this a professional law firm?

So now almost 3 WEEKS later and nobody in that law firm has figured out how to file arbitration papers yet? Sounds like there's a creek with no paddle over there. If I

had a coworker who was HARASSING someone I'd let them BURN!

That law firm is ridiculous. I've already filed questions with arbitration asking what the delay is so we'll see what they say.

HELLO AGAIN Ms. Benito. As you are well aware Mr. Pandos filed his lawsuit in state court against me DEMANDING a jury trial, cried foul and wanted arbitration when his threats failed, got RETRAUMATIZED and has since disappeared from filing anything completely.
